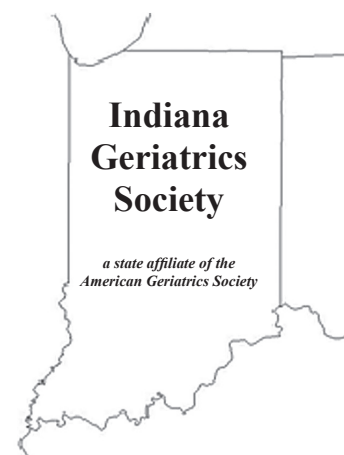

Updates in Geriatrics...Across the Continuum of Care

This conference is intended for physicians and non-physician interprofessional colleagues who provide medical care to elderly adults. Attendees will learn about innovations in making a difference in the quality of care for older adults, the impact of current issues in health care reform, and state-of-the-art updates in diagnosis, treatment, and management of a number of common health issues affecting the geriatric population.

Topics will specifically include updates on health care challenges for older adults across the continuum including care transitions and conducting family meetings, best comprehensive geriatric practice for the hip fracture patient, update on geriatric medications and interactions through discussion of the recently revised Beers List, wound care updates for the older adult, evaluation and management of dizziness and other balance problems, evaluation and management of diabetes in the older adults, annual progress report and impact of POST (Physician Orders for Scope of Treatment) in Indiana, and current issues in healthcare reform.

The Indiana Geriatrics Society (IGS) is a state affiliate of the American Geriatrics Society. The overall mission of IGS is to enhance the visibility of Geriatrics in Indiana. We hope to do this by providing local educational programs in geriatrics, promoting interdisciplinary care of older adults, and providing input to the national organization on public policy issues.

Course Objectives

At the conclusion of the program, participants should be able to:

- Demonstrate an increased awareness of key components for wound care in older adults.
- Describe the evaluation and treatment of dizziness and balance problems of older adults.
- Describe current ways to utilize an interdisciplinary approach to facilitate challenging family meetings.
- List the current issues in healthcare reform that affect future geriatric care for older adults.
- Identify the key components of the newly updated Beers List of geriatric medications and interactions critical for older adults.
- Apply quality of care principles for older adults with a hip fracture and the impact of transitions in care while addressing: delirium, malnutrition, osteoporosis, anticoagulation, pain control and safety.
- Incorporate research outcomes of utilizing the POLST form and future legal initiatives in Indiana; focusing on improving the quality of life for older adults and discussing care goals with all patients.
- Describe the current implications and treatments for diabetes in older adults.
